By developing and strengthening the National Focal Points capacities of European Countries, the Joint Action aims to provide quality access to the new EU4HEALTH Programme and to assure the complementarity with other regional, national and EU policies, funds and programmes.

As part NFP4Health, Task 6.3 "NFPs Twinning Programme" aims to share in a structured and outputoriented way approaches, good practices and tools between/among NFPs. Twinning programmes for NFPs focus on countries with low participation rates or newly nominated NFPs, to provide opportunities for exchange of experiences and good practices, in order to improve successful national NFP services.
